Detailed Rationale & Key Rating Drivers

CARE had, vide its press release dated November 13, 2020, placed the rating(s) of Dekson Castings Limited (DCL) under the 'issuer non-cooperating' category as DCL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. DCL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated September 29, 2021, October 09, 2021, October 19, 2021.

In line with the extant SEBI guidelines, CARE has reviewed the rating on the basis of the best available information which however, in CARE's opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating.

About the company

Dekson Castings Limited (DCL) was established in the year 1993 as a proprietorship concern and was later reconstituted as a private limited company in the year 2005 and later as a public limited company in February, 2014. DCL is engaged in the manufacturing of aluminium sand castings and gravity die castings (GDC) components and caters mainly to the two-wheeler segment in the auto industry as well as non-auto applications, viz, electrical energy. The manufacturing unit of the company is located in Aurangabad with an installed capacity of 1,290 Metric Tonne Per Annum (MTPA).
