Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated April 23, 2021, placed the rating(s) of Krushiraj Sugar Limited (KSL) under the 'issuer non-cooperating' category as KSL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KSL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 09, 2022, March 19, 2022, March 29, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings have been revised on account of non-availability of requisite information. The revision in rating also considers increase in overall debt in FY21 as compared to FY20.
