Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated December 23, 2021, placed the rating(s) of Kaadambary Ricetech Private Limited (KRPL) under the 'issuer non-cooperating' category as KRPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. KRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated November 08, 2022, November 18, 2022, November 28, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
