It acquired its present name in July'2015. JMHCL is part of the Lux group, based out of Kolkata. JMHCL was engaged in manufacturing and marketing of hosiery undergarments. JMHCL was focused on women innerwear and outerwear and marketed its products under the brand names of GenX, KoolZ, Touch, Karishma and Target. Currently, JMHCL has been amalgamated with LIL.
