Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated February 01, 2021, placed the rating(s) of Hyderabad Ring Road Project Private Limited (HRRPPL) under the 'issuer non-cooperating' category as HRRPPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. HRRPPL continues to be non-cooperative despite repeated requests for submission of information through email dated December 18, 2021, December 28, 2021, January 07, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Hyderabad Ring Road Project Private Limited (HRRPPL) is a special purpose vehicle (SPV) promoted by consortium of Era Infra Engineering Limited and Induni CIE SA, for executing and operating a 8-lane expressway (Narsingi to Kollur from km 0.00 to km 12.00 package) under Phase II of Outer Ring Road project of Hyderabad Growth Corridor Limited (HGCL, in which 74% stake is held by Hyderabad Metropolitan Development Authority (HMDA)) on Build Operate Transfer (BOT Annuity) basis.
