Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 21, 2021, placed the rating(s) of Mendine Pharmaceuticals Private Limited (MPPL) under the 'issuer non-cooperating' category as MPPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 06, 2022, April 17, 2022, April 26, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Later in December 1975, it was converted into private limited company and the name of the company changed to the current one. Currently, the company is managed by Mr. Probhas Bondhu Chakraborty and Mrs. Kalpana Chakraborty. Since its inception, the company has been engaged in manufacturing of pharmaceutical products like carmozyme, amirid, catarex-at, growly etc. at its plant located at Maheshtala, Kolkata, West Bengal with installed capacity of 18,00,000 liters per year. The manufacturing facility of the company has ISO 9001: 2015 certification which enables wide acceptance of its products in the market.
