Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 22, 2021, placed the rating(s) of Anantshree Polymers Private Limited (APPL) under the 'issuer non-cooperating' category as APPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. APPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 08, 2022, May 18, 2022, May 28, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Anantshree Polymers Private Limited (APPL) was incorporated in 2011, by Kayan family belonging to Kolkata to set up a unit for manufacturing polypropylene (PP) / high density polyethylene (HDPE) based woven sacks. The unit was setup at an aggregate cost of Rs.9.55 crore and the company commenced operations from September 2013 onwards with an installed capacity of 3,285 metric tons per annum (MTPA).
