Detailed Rationale & Key Rating Drivers

CARE had, vide press release dated June 17, 2020, had placed the ratings of Indsur Global Limited (IGL) under the 'Issuer Non-cooperating' category as the company had failed to provide information for monitoring of the ratings and had not paid the surveillance fees for the rating exercise as agreed to in its rating agreement. IGL continues to be non-cooperative despite requests for submission of information through phone calls and e-mails dated May 03, 2021, May 13, 2021 and May 23, 2021.

In line with the extant SEBI guidelines, CARE has reviewed the rating on the basis of the best available information which however, in CARE's opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating.

About the company

Incorporated in 1994, Indsur Global Limited (IGL) [formerly known as HGI Foundries – unit of Aditya Birla group located in Halol, Gujarat] is a closely held company taken over by Indsur group in the year 2004. Currently, the company is engaged in the business of manufacturing of insulator and auto castings, with insulator castings contributing. The company generates majority of its revenue from the domestic market and exports formed approximately 20% of the revenue base (during FY17) mainly to USA and Germany.
