### Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated October 11, 2021, placed the rating(s) of Om Shiv Lumbers Private Limited (OSLPL) under the 'issuer non-cooperating' category as OSLPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. OSLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 27, 2022, September 06, 2022, September 16, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Gandhidham-based (Gujarat), OSLPL was incorporated in March 2012 by Mr. Deepak Khatwani and Mrs. Bhagwati Khatwani. It is engaged in trading and processing of timber products namely wooden plates, face veneers, ready pallets, etc. OSLPL also perform job work for log dimension setting. At present, 27 employees are working under the company. There are 3 sets of vertical and horizontal sawing machines with installed capacity of 1500 cubic feet per day. Both the machineries and factory premises are rented
