Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated February 09, 2021, placed the rating(s) of A C Strips Private Limited (ACSPL) under the 'issuer non-cooperating' category as ACSPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. ACSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated December 26, 2021, January 06, 2022, January 15, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of ACSPL have been revised on account of non-availability of requisite information. The ratings also factored in significant decline in scale of operations, operating profitability, deteriorated capital structure and debt coverage indicators during FY21.

A C Strips Private Limited (ACSPL) was incorporated during August 1995 to initiate an iron and steel products manufacturing unit. The company installed a TMT bar manufacturing unit at Urla Industrial Complex in Raipur with an installed capacity of 30,000 MTPA. ACSPL sells its product under the brand name of "Swadeshi 500 TMT". The day-to-day affairs of the company are looked after by Mr. Dhiraj Surana, Director, along with other directors and team of experienced personnel.
