### Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated April 28, 2021, placed the rating(s) of Pacific Plastic Industries (PPI) under the 'issuer non-cooperating' category as PPI had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. PPI continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated March 14, 2022, March 24, 2022, April 03, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Daman based, PPI was originally established in the year 1999 as a partnership firm; reconstituted in 2007 by Mr. Rupesh Agrawal and Mr. Anand Goyal. Currently, the firm is engaged into manufacturing of flexible laminates, biaxially-oriented polypropylene (BOPP) pouches and stationery accessories, PVC Shrink Sleeves and Poly Propylene (PP) from its manufacturing facility located at Daman, with an installed capacity of 1,200 Metric Tonne Per Annum (MTPA) as on March 31, 2018.
