Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 29, 2021, placed the rating(s) of Balkrishna Spintex Private Limited (BSPL) under the 'issuer non-cooperating' category as BSPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. BSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 15, 2022, May 25, 2022, June 04, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

About the Company

Rajkot-based (Gujarat), BSPL is a private limited company incorporated in September, 2013 by Mr. Arvind Raichura, Mr.Girish Raichura, Mr.DipakRaichura, Mr.NathalalRaichura and Mr.MiteshKotecha. Apart from BSPL, the group is in the business of cotton ginning and pressing through its group companies, M/S Balkrishna Ginning and Pressing Factory and trading of cotton seeds and cotton bales through Balkrishna Cotspin. BSPL manufactures combed cotton yarn of finer quality with 30s count and operates from its sole manufacturing facility located at Sanosara, Rajkot. BSPL has total installed capacity of 16,416 spindles to produce 4380 metric tonne per annum (MTPA) of cotton yarn as on March 31, 2017. The major raw material for manufacturing cotton yarn is ginned cotton which is being procured from the local market of Rajkot.
