Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 17, 2021, placed the rating(s) of North East Ferro Alloys Company Private Limited (NEFACPL) under the 'issuer non-cooperating' category as NEFACPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. NEFACPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 03, 2022, August 13, 2022, August 23, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

North East Ferro Alloys Co. Pvt. Ltd. (NEFACPL) incorporated in July, 2008 and having commenced commercial operation from April, 2009 was promoted by Goyal Family of Darjeeling, West Bengal. The company is engaged in manufacturing of mild steel (MS) Ingots (capacity - 24,000 MTPA) with plant being located at Darjeeling, West Bengal. Apart from manufacturing, it is also involved in trading activities of sponge iron. Apart from India, the company also sells MS Ingots internationally by exporting the same to Bhutan.
