Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 22, 2021, placed the rating(s) of Bhuwneshwar Pathak Construction Private Limited (BPCPL) under the 'issuer non-cooperating' category as BPCPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. BPCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 08, 2022, May 18, 2022, May 28, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of BPCPL have been revised on account of non-availability of requisite information. The ratings also factored in significant decline in scale of operations, occurring of net losses and deteriorated capital structure during FY21.

Since its inception, the company has been engaged in civil construction, erection and maintenance activities. BPCPL is an ISO 9001:2008 certified company for its civil engineering services. The company derives its major revenue (97.97% of total revenue of FY19) from construction/erection & maintenance of telecommunication transmission lines and balance revenue from other general civil construction activities.
