# **Detailed Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated August 16, 2021, placed the rating(s) of Maa Tara Rice Mills (MTRM) under the 'issuer non-cooperating' category as MTRM had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MTRM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 02, 2022, July 12, 2022, July 22, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of MTRM have been revised on account of non-availability of requisite information.

#### **About the Firm**

Maa Tara Rice Mills (MTRM) was established as a partnership firm in January 1997 by the Shaw family. Moreover, the commercial operations of the firm commenced from April 1997. The firm is engaged in milling of raw rice, bran and husk. The milling unit of MTRM is located at Budge Budge, West Bengal with a paddy processing capacity of 80,000 metric tons per annum (MTPA). MTRM procures paddy from farmers & local agents across the district of South 24 paraganas and sells its finished products through the wholesalers and brokers located in West Bengal. MTRM has two associate entities namely Maa Tara Agro Products and Baba Jatadhari Agro (India) Private Limited which are engaged in processing of agro commodities
