Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 29, 2021, placed the rating(s) of Nilkanth Concast Private Limited (NCPL) under the 'issuer non-cooperating' category as NCPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. NCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 14, 2022, June 24, 2022, July 04, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Incorporated in 2003, NCPL is promoted by Mr. Chandrashekhar Ayachi. NCPL has an integrated steel plant and manufactures sponge iron, M.S. billets and TMT bars. NCPL sells its TMT bars under the brand name "Nilkanth". It has installed capacity of 72,000 metric tonnes per annum (MTPA) for sponge iron, 90,000 MTPA for billets & TMT bars along with a 10 Mega-Watt (MW) captive power plant. The manufacturing unit of NCPL is located at Kutch district in Gujarat.
