Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 20, 2021, placed the rating(s) of Hillsfood Agro Beverages Private Limited (HABPL) under the 'issuer non-cooperating' category as HABPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. HABPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated August 06, 2022, August 16, 2022, August 26, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Hillsfood Agro Beverages Private Limited (HAB) was incorporated in August, 2013 and is currently being managed by Mr Pradeep Kumar Gupta and Mr Anuj Kumar Jindal. HAB has set up a fruit juice processing unit at Baddi, Himachal Pradesh with an installed capacity of about 13,500 Kilo litres of juice per annum as on March 31, 2017. The company started commercial operations in April-2015. The company sells its products viz mango juice, apple juice, mixed juice etc under the brand name 'Juicewala' to various wholesalers and retailers located in different states of India through its network of super stockiest (15).
