Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated March 16, 2021, placed the rating(s) of Moon House Projects Limited (MHPL) under the 'issuer non-cooperating' category as MHPL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated January 30, 2022, February 09, 2022, February 19, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

Incorporated in August 2009, Moon House Projects Limited (MHPL) was promoted by Mr. Niranjan Kumar Singh and his family members. Currently; the company is being managed by Mr. Niranjan Kumar Singh, Mr. Rohit Kumar Singh, Mr. Kamta Prasad Singh, Mr. Manoranjan Kumar, Mr. Sudhir Kumar Singh, Mr. Randhir Kumar Singh and Mrs. Renu Kumari. Since its inception, the company has been engaged in construction and allied activities mainly for south eastern railway. MHPL secures work contracts through tender and executes orders mainly for south eastern railway. The company has an order book position of Rs.154.87 crore (4.98x of TOI of FY20) as on January 28, 2021 which is to be completed by December 2022.
