Rating Rationale

The rating assigned to back facilities of Andhra Pradesh State Road Transport Corporation (APSRTC) continues to remain constrained on account of delays in servicing of debt obligations.

Background

APSRTC was established on January 11, 1958, in pursuance of the Road Transport Corporations Act, 1950, with an objective of providing road transport facilities in the state of Andhra Pradesh (AP) and neighbouring states. The corporation was started with contributions from the Government of Andhra Pradesh (GoAP) and central government in the form of interest-bearing loan capital which was later converted into equity capital in the year 1992. As on March 31, 2013, GoAP has 67% stake and Government of India has 33% stake in the corporation.

APSRTC reported a total operating income of Rs.7,711.48 crore (Rs.6,749.92 crore in FY12) and a net loss of Rs.80.71 crore (Rs.585.31 crore in FY12) in FY13 (FY refers to period April 01 to March 31).
