## **Detailed Rationale & Key Rating Drivers**

The rating assigned to the bank facilities of APT Packaging Limited (APL) factors in the ongoing delays in servicing of term loan.

## **Key Rating Weakness**

**Delay in debt servicing obligations:** As per the interaction with the banker and as reflected in term loan statement, there are ongoing delays in servicing of interest and principal payment. The delays are on account of the stretched liquidity position of the company.
