Alpa Laboratories Limited (ALL) was formed in 1968 as a partnership concern by Mr. M.S Chawla, Mr Purushottam R. Patel and Mr P.C. Shah. Further, in 1988, the constitution was changed to private Limited company and subsequently in 2000, the company was converted into public limited company and resumed its current name. ALL was listed on BSE and NSE in August, 2007.

ALL is engaged in manufacturing of pharmaceutical formulation covering varies range of products in human use such as capsules, creams, gels and ointments, ear and eye drops, injections, tablets, in veterinary use includes boluses, injections and intra-mammary infusions and sells these products under the registered trade name 'Alpa'. The company caters both domestic and international market, where it exports its products to Nigeria, South and Central America, Africa, Russia, Ukraine and Kazakhstan and so on and also imports raw materials majorly from China.
