## CARE REAFFIRMS THE RATINGS ASSIGNED TO THE BANK FACILITIES OF BHARAT INSECTICIDES LIMITED

CARE, while arriving at the rating of BIL, has taken combined view of the other group companies B.R Agrotech Ltd (BRAL) and Bharat Rasayan Ltd (BRL) due to integrated and interlinked business under the same management.

### Rating Rationale

The ratings assigned to the bank facilities of Bharat Insecticides Ltd (BIL) continues to take into account the integrated operations of the Bharat group with its presence in the entire value chain of the pesticide segment, long-standing experience of the promoters in the pesticides industry and established track record of operations. The ratings further derive strength from the group's wide distribution network, established brands, extensive product portfolio, large number of product registration and comfortable financial risk profile of the group marked by comfortable capital structure, strong debt coverage indicators and healthy liquidity position.

However, these rating strengths are partially offset by the working capital intensive nature of operations, foreign currency fluctuation risks, regulatory risks, competitive and fragmented industry structure and high dependence on climatic conditions.

Going forward, sustainability of profitability, while increasing the scale of operations without any adverse impact on the capital structure and effective working capital management will remain the key rating sensitivities.

### Background

BIL was incorporated in February 1985 for manufacturing of technical grade pesticides. The constitution was changed to closely held public company with the present name in 1985. Over the past years, the company has added various products in its portfolio which now includes wide range of insecticides, fungicides, weedicides and herbicides. The company has capacity of manufacturing 32,500 MTPA of formulations and technical grade pesticides of various kinds. BIL is a part of the Bharat group with Bharat Rasayan Ltd (rated 'CARE AA-/ CARE A1+') is the flagship company of the group which also comprises of BR Agrotech Ltd (BRAL). The group has a presence in diverse segments of the agrochemical industry with each group company focusing and specializing in a distinct segment. The group has synergetic operations through integrated and interlinked business processes of the group companies with all the companies being managed by the same management. BRL is engaged in the core business activities of manufacturing of technical grade pesticides (a B2B segment) which is a key ingredient for formulations and used for captive consumption to some extent, whereas the other group companies are engaged in value-added product of formulations (B2C segment) and packaging (Pet Bottles).

BIL had a total income of Rs.303.88 crore with a PAT of Rs.33.08 crore in FY15 (refers to the period April 1 to March 31) as compared with the total income of Rs.269.23 crore and a PAT of Rs.31.37 crore in FY14. On a combined basis, the group reported PAT of Rs.88.34 crore on an operating income of Rs.847.84 crore during FY15 (as compared with PAT of Rs.67.69 crore on an operating income of Rs.731.07 crore during FY14)
