CARE REAFFIRMS THE RATING ASSIGNED TO THE BANK FACILITIES OF BHARATI VIDYAPEETH PUNE

Rating Rationale

The rating assigned to the bank facilities of Bharati Vidyapeeth Pune (BV) continues to derive strength from the experienced management council, large number of institutes offering diverse courses, adequate infrastructural facilities and increased demand for quality technical and management education. The rating further continues to take into account moderate financial risk profile characterised by increase in scale of operations, satisfactory capital structure and moderate debt coverage indicators. The rating also takes a note of deferral of the large debt-funded capital expenditure (capex) plan which would improve debt profile in the near future.

The rating continues to remain constrained by relatively lower surplus, competition from other renowned engineering and management institutes in and around Maharashtra.

The ability of BV to sustain revenue growth as well as complete its ongoing and upcoming projects without impacting the capital structure and debt coverage indicators would be the key rating sensitivity.

Background

BV was established in the year 1964 by Dr Patangrao Kadam. The day-to-day administration is managed by a governing council headed by secretary, Dr Vishwajeet Kadam who in turn is assisted by three joint secretaries and five directors. BV is registered under the Societies Registration Act, 1860, and the Bombay Public Trust Act, 1950. BV provides education in various streams through its various campuses in Maharashtra. It runs more than 160 institutes including 101 schools and 59 institutions. BV operates through eight major centres in Maharashtra, viz, Pune, Mumbai, Kadegaon, Panchgani (Satara), Sangli, Solapur, Kolhapur and Karad. It also has three institutes in New Delhi offering graduation and post-graduation courses. The Government of India (Ministry of Human Resource Development) on the recommendation of the University Grants Commission, New Delhi, accorded the status of a Deemed University to BV with effect from April 26, 1996. As on December 31, 2015, the total number of students enrolled in BV was more than 7.5 lakh and the number of teaching and non-teaching employees was about 9,000.

During FY15 (refers to the period April 1 to March 31), BV's total operating income stood at Rs.583.69 crore (Provisional) and reported a surplus of Rs.51.34 crore as against the total operating income of Rs.557.26 crore and a surplus of Rs.67.94 crore in FY14.
