CARE REAFFIRMS THE RATINGS ASSIGNED TO THE ENHANCED BANK FACILITIES OF COCHIN SHIPYARD LIMITED

Rating Rationale

The ratings continue to factor in the well-established operations and long-standing track-record of more than three decades of Cochin Shipyard Ltd (CSL), strength from 100% Government of India (GoI) ownership, comfortable capital structure, diversified revenue stream to an extent and the potential for CSL to acquire strategic importance on completion of the Indigenous Aircraft Carrier project. The ratings also take note of the consistent strong financial performance of the company over the past few years ended March 2014.

The above ratings, however, continue to be constrained by the operational risk on account of the complex nature of operations due to simultaneous execution of multiple vessels and activities, exposure of CSL to foreign exchange fluctuation risk and cyclical nature of the shipbuilding industry.

Change in the government ownership, any large debt-funded expansion in the future and maintenance of its comfortable capital structure and order book position are the key rating sensitivities.

Background

Incorporated in 1972, CSL is wholly-owned by the GoI and operates a shipyard designed and constructed under technical collaboration with M/s Mitsubishi Heavy Industries, Japan. The yard commenced the shipbuilding operations in 1978 and the company is a Category I Mini Ratna (since July 2008).

CSL posted a PAT of Rs.194 crore on a total income of Rs.1,695 crore in FY14 (refers to the period April 1 to March 31) as against a PAT of Rs.185 crore on a total income of Rs.1,634 crore in FY13. As per the provisional results for H1FY15, CSL has posted a PAT of Rs.123 crore on a total income of Rs.894 crore.
