Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the outstanding ratings of 'CARE BB; Stable (Double B; Outlook: Stable)' and 'CARE A4 (A Four)' assigned to the bank facilities of Denis Chem Lab Limited (DCLL) with immediate effect. The above action has been taken at the request of DCLL and 'No Objection Certificate' received from banks that have extended the facilities rated by CARE.

About the Company

DCLL was incorporated in July, 1980 as Denis Chem Lab Private Limited by Himanshu C. Patel, Nirmal H. Patel, Anar D. Patel and other family members. Subsequently, in April 1982, it was converted into a closely held public limited company with the name of DCLL. DCLL is engaged into manufacturing of Intravenous Fluids (IVF) both in glass and plastic bottles using the BFS (Blow-Fill - Seal) technology. DCLL's WHO-GMP certified manufacturing unit is located at Chhatral (Gandhinagar) and has installed capacity for producing Transfusion Solution (T.S) in glass bottles and plastic bottles aggregating to 85 million bottles per annum as on March 31, 2017.
