#### **Company Background**

GTV Engineering Limited (GTV) was incorporated in 1990 by Mr Mahesh Agrawal along with other family members in the name of Gwalior Tanks & Vessels Private Limited (GTVPL). In 1994, the company was listed in BSE and CSE and the name was changed from GTVPL to Gwalior Tanks & Vessels Limited. Further, in 2006, the name of the company was again changed to its current name. GTV is a Hi-Tech heavy steel fabrication and machining company working as a subcontractor for various engineering companies and undertakes steelwork and technological fabrication work of plants for the cement, steel, railways, power and heavy industries.
