GPBL was incorporated on January 12, 2012, and is primarily engaged in manufacturing of kraft paper and mild steel ingots. GPBL is the resulting company pursuant to the scheme of arrangement implemented in FY14 as per which erstwhile Genus Paper Products Limited (GPPL) was merged into Genus Power Infrastructures Limited (GPIL) and the 'Non Power Infrastructure Business' of GPIL was demerged into GPBL. The manufacturing facility of the company is located at Moradabad, Uttar Pradesh.
