The company is part of the Hindusthan Group which is promoted by Mr Rajendra Prasad Mody and family. The company is in the manufacturing of the bare overhead conductors with annual installed capacity of 66,000 MT (metric tons) and HT insulators with annual installed capacity of 15,379 MT.
