Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the outstanding ratings of 'CARE AA-; Stable/ A1+' [Double A minus; Outlook: Stable/ A one plus] assigned to the bank facilities of erstwhile IFGL Refractories Ltd. with immediate effect. The above action has been taken pursuant to the scheme of Amalgamation approved by the National Company Law Tribunal (NCLT), wherein erstwhile IFGL Refractories Ltd. has been merged with IFGL Exports Ltd. (subsequently renamed as IFGL Refractories Ltd.) with effect from 1st April 2016.

IFGL Refractories Ltd, incorporated in 1989, was the flagship company of S K Bajoria group of Kolkata. The company was engaged in manufacturing of special refractories and operating systems for the steel industry and bio-ceramic products at its factory at Rourkela, Odisha with an aggregate manufacturing capacity of shaped refractories (7,76,000 pcs), unshaped refractories (24,000 MT), shaped ceramics (10,000 pcs) and unshaped ceramics (50.0 kg)
