## Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

The Issuer Rating assigned to Ichalkaranji Municipal Council under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) Scheme of the Government of India was a one-time exercise with a validity of one year. Upon expiry of the said validity period, the aforesaid Issuer Rating stands withdrawn with immediate effect.

## About the Company

The AMRUT Scheme was launched in 2015 by Ministry of Urban Development, Government of India, aiming at urban renewal projects for establishment of infrastructure with adequate sewerage networks and water supply for urban transformation. A total of 500 cities with population of above 1 lakhs are to be covered under this scheme. Government of India is to invest Rs. 50,000 crore under this mission and State Government would contribute depending upon population of the cities in the next 5 years. As a part of the financing of this programme, apart from State and Centre's contribution, Urban Local Bodies (ULB) will be required to raise some funds on their own as well. Ichalkaranji Municipal Council is one of the ULBs under the AMRUT scheme in the State of Maharashtra.
