## CARE REAFFIRMS THE RATINGS ASSIGNED TO THE BANK FACILITIES OF K.P.R MILLS LTD.

#### **Rating Rationale**

The ratings continue to factor in the promoters' established track record in the textile industry, KPR being one of the larger players in the Tiruppur yarn market and the integrated nature of its operations. The ratings, are, however, constrained by deterioration in financial performance of the company during FY09 characterized by less than anticipated growth in sales especially in the garment exports division on account of the economic slowdown in key export markets, sharp fall in operating margins and higher interest costs due to the debt funded expansion undertaken leading to lower profits.

Notwithstanding the improvement in performance reported by the company in 9MFY10, the ability of the company to improve sales especially in the garment division, while at the same time maintaining overall margins in light of the operating environment characterized by volatile cotton prices and poor power supply situation in Tamil Nadu would be critical to the prospects of the company. This along with the possible impact of the derivative contracts entered into by the company, on the financial risk profile of the company would be the key rating sensitivities.
