Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the outstanding ratings of 'CARE A+; Stable/CARE A1+' [Single A Plus; Outlook: Stable/A One Plus] assigned to the bank facilities of Lux Industries Limited (LIL) with immediate effect. The above action has been taken at the request of LIL and 'No Objection Certificate' received from the banks that have extended the facilities rated by CARE.

About the Company

LIL was incorporated as Lux Hosiery Industries Ltd. in July, 1995 and subsequently its name was changed to its present name in October, 2007. Currently, LIL is engaged in manufacturing and marketing of innerwear, thermals and casuals under various brands, with 'LUX' being its flagship brand. LIL is the flagship company of the LUX group.

The company reported PAT of Rs.79.23 crore on total operating income of Rs.1,140.83 crore in FY18 as compared to PAT of Rs.59.65 crore on total operating income of Rs.959.13 crore in FY17. During H1FY19, LIL reported PAT of Rs.40.13 crore on total operating income of Rs.540.26 crore.

Status of non-cooperation with previous CRA: Vide press release dated June 4, 2015, CRISIL suspended its ratings on the bank facilities of LIL on account of non-cooperation by LIL with CRISIL's efforts to undertake a review of the ratings outstanding.
