CARE REAFFIRMS THE RATINGS ASSIGNED TO THE BANK FACILITIES OF M & B ENGINEERING LIMITED

Rating Rationale

The ratings of M&B Engineering Limited (MBEL) continue to take into account its established operations in the Pre-Engineered Building (PEB) industry along with the vast experience of its promoters in the construction industry and its moderate leverage.

The ratings, however, continue to remain constrained by high working capital intensity of its operations and its moderate debt coverage indicators. The ratings are further constrained by susceptibility of its profitability to fluctuation in the raw material prices and foreign currency rates and its presence in a highly competitive industry where demand is linked to the overall economic scenario. The ratings also take note of the decline in its total operating income (TOI) during last 2 years ended FY15 (refers to the period April 1 to March 31).

MBEL's ability to increase its scale of operations along with improvement in its profitability and debt coverage indicators in a competitive industry scenario shall be the key rating sensitivity.

Background

Ahmedabad-based (Gujarat) MBEL is engaged in the manufacturing & installation of PEB and installation of self-supported steel roofing systems. It is a part of the M&B group (MBG) of Ahmedabad which is engaged in infrastructure sectors like power, highways, irrigation, industrial construction, engineering and infrastructure business since 1951. MBG was promoted by late Mr Manibhai Patel, and currently the group's operations are looked after by Mr Hasmukhbhai Patel and his family members.

MBEL was originally incorporated as Manibhai & Brothers Construction Private Limited and was subsequently converted into a public limited company in FY11. It has two divisions - "Proflex division" which is into installation of self-supported steel roofing system and "PEB/Phenix division" which is into design, manufacturing and installation of PEB.

As per the audited results for FY15, MBEL earned a PAT of Rs.2.91 crore on a total operating income of Rs.487.95 crore as against a PAT of Rs.4.28 crore on a total operating income of Rs.531.52 crore in FY14. Furthermore, as per un-audited results for 9MFY16, MBEL has registered a PBT of Rs.6.62 crore on a total operating income of Rs.361.65 crore.
