Incorporated in 1972, MDOL (formerly known as Advent Pharma Pvt Ltd), is engaged in manufacturing of Active Pharmaceutical Ingredient (API's) / Bulk Drugs. The company is promoted by Mr Govardhan Dhoot and his family. MDOL got converted into a public limited company in 2001 and later, in 2006, the company got listed on BSE/NSE.

For the financial year ending March 31, 2017 the PDOL reported total revenue of Rs.303.14 crore with net profit of Rs.23.70 crore.
