NFIL's business units are refrigerant gasses, inorganic/bulk fluorides, specialty fluorochemicals and Contract Research and Manufacturing Services (CRAMS). The company's presence is spread across in India and globally in countries including U.K, United States of America (USA) amongst others. In FY18, export sales contributed 52% of total sales in the company. The manufacturing facilities are located in Surat, Gujarat, and Dewas, Madhya Pradesh which are strategically located near ports. The research and development centre is located in Surat.
