Rating Rationale

The revision in ratings takes into account persistent delays in payment towards principal and interest obligations to banks.

Company Profile:

Punjab Chemicals and Crop Protection Limited (PCCPL), involved in manufacturing of various agro chemicals, industrial chemicals and chemicals for the pharmaceutical industry, faced substantial liquidity pressures in FY10 due to volatility in raw material prices, disruption of operations due to a fire in its unit. PCCPL posted total income of Rs.318 crore and incurred net loss of Rs.41 crore in FY10 compared to total income of Rs.489 crore and PAT of Rs.5 crore in FY09. The overall gearing of the company stood at 4.30x as on March 31, 2010.
