CARE has withdrawn the outstanding ratings of 'CARE D; Issuer Not Cooperating' [Single D: Issuer Not Coperating] assigned to the bank facilities of RG Residency Private Limited (RGRPL) with immediate effect. The above action has been taken at the request of RG Residency Private Limited and 'Loan Closure Letters' received from the banks that had extended the facilities rated by CARE.

About the Company

R.G. Residency Private Limited (RGRPL) was incorporated in 2010 & is engaged in real estate business. Historically, the group was mainly into development of commercial projects in Delhi and has successfully executed 14 commercial/retail projects in Delhi. In 2010, the company ventured into residential group housing projects in Noida and Greater Noida region. The group was promoted by Mr Jai Bhagwan Goyal, a qualified Civil Engineer, who has more than 40 years' experience in construction.

RG Residency is being developed on a total area of 12.62 acres in Sector-120, Noida which is approximately 6.5 km from Noida City Centre Metro Station. The project involved development of 1750 flats.
