Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the outstanding ratings of 'CARE D' assigned to the bank facilities of RMG Alloy Steel Ltd. with immediate effect. The above action has been taken at the request of RMG Alloy Steel Ltd. and 'No Objection Certificate' received from the bank that has extended the facilities rated by CARE and 'No Dues Certificate' received from several other banks stating that there is no amount outstanding under the facility/ loan as on date.

About the Company

Promoted by Mr. V.C. Saraf and Mr. R.C. Saraf, RMGL is engaged in manufacturing of carbon and alloy steel seamless pipes/tubes with captive facilities for steel melting and continuous bloom/ingot casting at Jhagadia, Gujarat.

Earlier, the company was under Joint Lender's Forum (JLF) to finalize the overall debt resolution plan under Strategic Debt Restructuring (SDR) scheme including conversion by lenders of debt into equity which had been invoked on October 24, 2017. However pursuant to RBI's circular dated February 12, 2018; the SDR scheme had been repealed.

During H2FY18, Welspun Steel Limited (RMG's strategic partner) along with private investors infused ~Rs.405 Crore in RMG, of which majorly is used to repay the outstanding debt and revive the company.

During FY18, RMG registered total operating income of Rs.238.94 Crore and losses of Rs.54.11 Crore.
