On December 26, 2014, the firm changed its constitution to partnership concern with Mr. Ramdas Aswani, Mrs. Chandni Dudani and Mrs. Sandhya Dudani joining the firm as a partners and shares profit & loss in the ratio of 40:30:30 respectively.

SI is mainly engaged in the business of processing of gram as well as trading of Pulses/agro commodities such as masoor, moong, toor, dhan, paddy and gram dal, etc. The firm purchases gram and other agricultural commodities from local farmers as well as mandis and sells processed gram dal and agro commodities to traders in South India. It sells its product through brokers under the brand name of "Double Telephone", "Kargil" and "Rocket".
