Detailed Rationale & Key Rating Drivers

CARE has been seeking information from Sharon Bio-Medicine Ltd to monitor the rating(s) vide e-mail communications/letters dated December 20, 2017; December 13, 2017; July 5, 2017 and numerous phone calls. However, despite our repeated requests, the company has not provided the requisite information for monitoring the ratings. In line with the extant SEBI guidelines, CARE has reviewed the rating on the basis of the publicly available information which however, in CARE's opinion is not sufficient to arrive at a fair rating. The rating on Sharon Bio-Medicine Ltd's bank facilities will now be denoted as **CARE D; ISSUER NOT COOPERATING***.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings take into account the ongoing delays in debt servicing owing to the strained liquidity position.

Detailed description of the key rating drivers

At the time of last rating on December 15, 2016, the following were the rating weaknesses updated for the information available from announcement of financial results on BSE website on December 8, 2017.

Key Rating Weaknesses

Delays in servicing the debt

The rating of Sharon Bio Medicine Limited was revised taking into account the ongoing delays in debt servicing owing to the strained liquidity position. As per financial results published on BSE website, in FY17 Sharon Bio Medicine Limited has reported revenues of 133.81 crore (Previous Year: 390.05 crore) and losses of 347.86 crore (Previous Year: 242.08 crore). Besides, Sharon Bio Medicine Limited has filed with NCLT for Corporate Insolvency Resolution Process. NCLT had appointed interim resolution professional (IRP) for the company and under the said orders the powers of the BOD stands suspended and the management of the affairs of the company stands vested in the hands of IRP.

The company has a diversified product portfolio with presence mainly in acute therapies such as anti-infectives and anti-biotics along with presence in chronic therapies such as diabetes and cardiovascular. The company has three manufacturing facilities, two at Taloja in
