Detailed Rationale & Key Rating Drivers

CARE has been seeking information from Shri Kedareshwar Builders & Developer private Limited to monitor the ratings vide e-mail communications dated October 01, 2018; October 16, 2018 & November 14, 2018 and numerous phone calls. However, despite our repeated requests, the company has not provided the requisite information for monitoring the ratings. In line with the extant SEBI guidelines, CARE has reviewed the rating on the basis of the publicly available information which however, in CARE's opinion is not sufficient to arrive at a fair rating. The rating on SKBDPL bank facilities will now be denoted as CARE D; ISSUER NOT COOPERATING* considering ongoing delays in debt servicing.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating.

Key Rating Weakness
