Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the outstanding ratings of 'CARE BBB-, Stable/ CARE A3' (Triple B Minus; Outlook: Stable/ A Three) assigned to the bank facilities of Shristi Infrastructure Development Limited with immediate effect. The above action has been taken at the request of Shristi Infrastructure Development Limited and 'No Objection Certificate'/'No Due Certificate' received from the banks that have extended the facilities rated by CARE.

About the Company

Shristi Infrastructure Development Corporation Ltd (SIDCL), incorporated in 1990, was promoted by the promoters of Kolkata-based SREI group. SIDCL started commercial operation in 1999. The company is engaged in construction of roads, bridges, buildings, power, hotel, etc. SREI group has been in operation since 1989 with Shri Hemant Kanoria being the main promoter of the group. With effect from March 31, 2016, Shristi Housing Development Ltd (SHDL), a wholly owned subsidiary of SIDCL got merged with SIDCL vide High Court order dated Feb 16, 2016.

In FY17, SIDCL reported PAT of Rs.3.17 crore (as against Rs.2.63 crore in FY16) on total operating income of Rs.101.22 crore (as against Rs.158.54 crore in FY16).
