Detailed Rationale, Key Rating Drivers and Detailed description of the key rating drivers

CARE has withdrawn the rating assigned to the bank facilities and non-convertible debentures issue of Suryoday Small Finance Bank Limited with immediate effect, as the company did not utilize the aforementioned bank facilities and repaid the aforementioned non-convertible debentures in full and there is no outstanding under the said facility and issue as on date.

About the Company

Incorporated in November 2008, Suryoday Small Finance Bank (SSFB) (erstwhile Suryoday Microfinance Ltd) is a Mumbai based small finance bank. SSFB commenced group lending business w.e.f. May 2009. Under the JLG model, SSFB provides micro loans to individual members in the group with each group consisting of five members and 2-6 groups forming a centre. The loans are provided to individual members in a group based on the mutual guarantee from members wherein each member is jointly responsible for the loan repayment of the centre. As on March 31, 2018, SSFB had Assets under Management (AUM) of Rs.1596 crore. The company was founded by Mr. R Baskar Babu, also Managing Director and Chief Executive Officer (MD & CEO) of SMFL. He has extensive experience of over 24 years in banking & financial sector having previously worked in Cholamandalam, HDFC Bank and GE commercial Finance.

In August 2016, RBI granted final approval to Suryoday to set up a Small Finance Bank (SFB). Suryoday Small Finance Bank commenced its operations as a Small Finance Bank on 23rd January, 2017.
