CARE has withdrawn ratings assigned to Lower Tier II Unsecured Subordinated Basel II compliant bonds (Series VI) of United Bank of India (UBI) with immediate effect as the rated bonds were fully redeemed on maturity i.e. March 25, 2019 and there is no outstanding under the said issue as on date.

United Bank of India (UBI), incorporated in 1950 with GoI having about 96.83% stake as on April 02, 2019 (92.25% equity stake as on Sept 30, 2018) subsequent to preferential allotment of equity shares of Rs.2,839 crore to the Central Government on March 29, 2019. Its major concentration of branches is in eastern and north-eastern India. Currently, the overall functioning of the bank is looked after by Shri Ashok Kr. Pradhan, MD & CEO (appointed w.e.f. Oct.01, 2018). He is assisted by Shri Ajit Kumar Das, Executive Director and Shri Rakesh Chandra Narayan, CFO along with various General Managers.
