## **About the Company**

Fusion Microfinance Pvt Ltd (FMPL) was originally incorporated as Ambience Fincap Pvt Ltd (AFPL) in September 1994. In May 2009, AFPL was acquired by then current promoters Mr. Devesh Sachdev and Mr. Ashish Tewari and renamed as FMPL to undertake microfinance business in India. FMPL started its microfinance operations in January 2010. FMPL received the registration as an NBFC-MFI from RBI on Jan 28, 2014, earlier it used operate as an non-deposit taking NBFC registered under RBI. FMPL provides loans to individual female members predominantly from rural areas in a Joint Liability Group (JLG) with each group consisting of five members.

As on June 30, 2018, FMPL has been operating across 16 states in India through a network of 391 branches providing a moderate geographical diversification to the loan portfolio. As on June 30, 2018, FMPL has ~9,70,000 active borrowers on a total AUM of Rs.1,563.87 crore, against AUM of Rs.1,303.87 crore as on March 31, 2018. During Q1FY1, FMPL has entered in 2 new states of Assam and Tamil Nadu.

During FY17, FMPL reported a PAT of Rs.4.10 crore on a total income of Rs. 201.04 crore as against PAT of Rs.13.42 crore on a total income of Rs.110.34 crore in FY16. During FY17 tangible Net worth of the company stood at 203.35 crore as against the 69.46 crore during FY16.
