

With sixteen hikes in May 2021, fuel prices now at all-time highs

Continuous fuel price hikes in May 2021

Nearly every alternate day of May 2021 witnessed fresh hikes of fuel prices in India. After witnessing a total of sixteen fuel price hikes, the month ended with all-time high prices in some metro cities of the country. Same number of hikes were previously seen in February 2021 (as shown in table 1).

In India's financial capital, Mumbai, petrol prices created a fresh record by crossing Rs. 100/litre for the first time, while diesel prices inched towards Rs. 92/litre on 31st May. Delhi witnessed petrol and diesel prices crossing Rs. 94/litre and Rs. 85/litre respectively, which refers to a cumulative hike of Rs. 3.83/litre (petrol) and Rs. 4.42/litre (diesel) for the month of May 2021.

Analysis of table 1 shows that fuel prices were hiked 42 times during CY2021 (Jan-May), compared with just 4 reductions in the same period. In the start of the ongoing calendar year, petrol prices hovered at ~Rs. 84/litre in Delhi, which at the end of five months rose by 12%, while diesel prices which stood at ~Rs. 74/litre on 1^{st} Jan 2021, rose by 15% as of 31^{st} May 2021.

Oil companies revise fuel rates based on the average price of benchmark fuel in the international market in the preceding 15days and foreign exchange rates. Fuel prices differ from state to state depending on the incidence of local taxes such as VAT and

freight charges. The highest VAT on petrol is levied in Rajasthan, followed by Madhya Pradesh and Maharashtra.

Price build-up at Delhi

An analysis of the price build-up as on 1st June 2021 of Indian Oil Corporation Ltd., shows that excise duty and VAT (Rs. 54.7/litre) comprise 58% of the retail selling price in Delhi for petrol, while in case of diesel, the VAT and excise duty is Rs. 44.3/litre, i.e. 52% of the retail price. However, when compared with start of the year (1st Jan 2021), such taxes and duties were Rs. 52.3/litre (petrol) and Rs. 42.7/litre (diesel), which comprised 62% and 58% for petrol and diesel respectively.

This shows that as fuel prices have risen over the past 5 months, the taxes and duties have also increased proportionately. The government have been able to generate incremental tax revenues of Rs. 2.4/litre (petrol) and Rs. 1.6/litre (diesel) over the past 5 months in Delhi.
